## **MARYLAND TOBACCO DIRECTORY (Participating Manufacturers)**

This directory identifies cigarette and “roll-your-own” tobacco brands and tobacco manufacturers that are in compliance with Title 16, Subtitle 5 of the Business Regulation Article of the Maryland Code. Specifically, §16-504(c) of the Business Regulation Article prohibits selling, offering or possessing for sale in Maryland for personal consumption cigarettes of a tobacco manufacturer or brand and brand family not included in this directory or in the directory of participating manufacturers.

From time to time the Attorney General will update the directory to add and delete manufacturers or brand families, pursuant to Md. Code, Bus. Reg. §16-504(b)(3). The Office of the Attorney General will notify licensed wholesalers of changes to the directory by electronic mail, to the address provided to the Attorney General on the License Wholesaler Address Reporting Form.

The Attorney General is the only source of compliant status. Licensed wholesalers should review their e-mail and this directory frequently to ensure that the tobacco products they possess or are considering possessing may be lawfully sold, possessed or distributed in Maryland.

A brand family’s listing on this directory certifies only that the brand family may be sold consistent with Title 16, Subtitle 5, of the Business Regulation Article of the Maryland Code. The stamping or sale of a brand family still may be prohibited by other provisions of Maryland law. Sales of clove cigarettes, for example, are prohibited in Maryland under Criminal Law Article § 10-106. Wholesalers remain responsible for ensuring that sales of brand families identified on the directory are consistent with all other provisions of Maryland law.

The directory includes an alphabetical listing of manufacturers that are participants in the Master Settlement Agreement, along with their respective brand families. The directory identifies brand families; it does not identify the brands that make up the particular brand family.
